4. FIRST AID MEASURES

Skin Contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance. 6. ACCIDENTAL RELEASE MEASURES
